2. If tuition is in arrears after 30 days, the school reserves the right to withhold services until satisfactory arrangements have been made with the Principal.
3. **Registration fee is NON-REFUNDABLE.**
4. **AS A PARISHIONER:**
 - A. I will attend Mass faithfully and ensure that my children do the same.
 - B. I will support my parish by using Sunday Envelopes, I will participate in parish ministry
 - C. If I do not meet the requirements outlined above, my tuition will be raised to the NON-PARISHIONER rate.
